## **Membership Terms and Conditions**

Date

- 1. Louisiana Range Gun Club facility is available for use by all members, guests of members, private citizen groups, and by the general public. Louisiana Range Gun Club memberships are available to provide preferred access, discounts for merchandise, services and facility use, and other benefits to be determined at the discretion of Louisiana Range Gun Club. Louisiana Range Gun Club membership is subject to the Membership Terms and Conditions stated herein. Membership will be granted and may be revoked at the sole discretion of Louisiana Range Gun Club.
- 2. As part of the consideration for membership, the member hereby agrees to remain a member and pay the annual membership dues for a period of not less than one (1) year from the date of this agreement. Louisiana Range Gun Club is entitled to recover its costs, including reasonable attorney fees, incurred in collecting sums due to Louisiana Range Gun Club under this or any other membership provision or otherwise. In the event a member must terminate a membership, Louisiana Range Gun Club will refund 50% of the unused portion on a pro-rated basis of unused months. A month shall include any part of a month. For example, if a membership that was paid in full and cancelled by the member in month 6 of 12 the member would receive a refund of 50% of the 6 months remaining on the membership.
- 3. Louisiana Range Gun Club may terminate a membership unilaterally if, in Louisiana Range Gun Club's sole discretion, a members conduct presents a safety hazard to the member or to any other user or Louisiana Range Gun Club personnel or to Louisiana Range Gun Club facilities. In the event Louisiana Range Gun Club terminates a membership, a member who has paid annual dues will have 50% of the unused portion refunded on a pro-rated basis of unused months. A month shall include any part of a month.

- 5. All members and guests of Louisiana Range Gun Club must follow all safety standards and range rules, and must read and agree to the terms of the Louisiana Range Gun Club waiver of liability, release of claims, and agreement to hold harmless, defend, and indemnify which is incorporated by reference into Louisiana Range Gun Club terms and conditions of membership. All first-time members and guests must participate in the Louisiana Range Gun Club orientation and watch the safety presentation before shooting at the range.
- 6. All guests must be accompanied by a member to be admitted to member-only areas. Members are responsible for all actions taken by their guests and will hold Louisiana Range Gun Club harmless for property damage, accidents and injuries to or caused by guests.
- 7. All members and guests are subject to the general policies and rules of operation and administration of Louisiana Range Gun Club, all of which are intended to provide a safe, professional, friendly, and family-oriented environment for the shooting sports.
- 8. Any member or guest of a member may be suspended or expelled from the Louisiana Range Gun Club facility for violation of the range rules or for behavior deemed unsafe by Louisiana Range Gun Club personnel. Decisions of Louisiana Range Gun Club management regarding suspension or expulsion are final.
- 9. If a member or a member's guest causes any damage to Louisiana Range Gun Club property, whether accidental, negligent, willful or otherwise, the member (and the member's guest) will be removed from the range and/or facilities and suspended or terminated from membership. The individual responsible for the damage may be civilly liable or criminally prosecuted. Louisiana Range Gun Club reserves the right to charge the member the costs for any such damage, regardless of whether the damage is caused by the member of the member's guest. Should court action be required to collect the damages, the member will also be liable for Louisiana Range Gun Clubs' attorney fees.
- 10. All Louisiana Range Gun Club members will need to provide a photo ID, and all members must present their photo ID whenever they use Louisiana Range Gun Clubs' facilities. All guests must present a photo ID before using Louisiana Range Gun Clubs' facilities.
- 11. Louisiana Range Gun Club membership(s) may not be transferred or sold.
